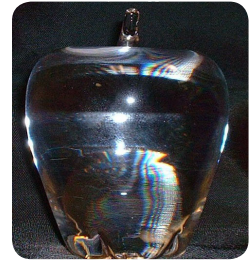

Process: The Chamber is seeking candidates for nomination. To present a candidate for nomination, please submit in writing, reasons why a Chamber member business should be considered for a nomination for the Crystal Apple Award. Please provide specific information/examples based on but not limited to one or more of the following criteria:

- Significant Improvement of Community Services
- Expanded Educational Opportunities
- Private Investment
- Job Creation
- Visible demonstration of confidence in the County's economic future
- Distinguished Involvement in Civic Affairs

All candidate recommendations submitted by the close of business on January 4, 2010, will be reviewed by the Chamber Board of Directors, who will vote to create a slate of five official nominees. The ballot of official nominees will then be mailed to the membership for voting. Votes received by the close of business on February 19, 2010 will be counted. The winner will be announced at the Crystal Apple Award Gala on February 26, 2010.
